I. MEETING CONVENED

III. WELCOME: GOVERNOR DANNEP P. MALLOY

Vice Chair Santa welcomed Governor Dannel P. Malloy to the meeting. The Governor remarked on the Commission's evaluation of pretrial release and detention and discussed his proposed reforms for the session.

IV. NATIONAL INSTITUTE OF CORRECTIONS PRESENTATION ON LEGAL AND EVIDENCE-BASED PRETRIAL RELEASE AND DETENTION

CONNECTICUT SENTENCING COMMISSION

Timothy Schnacke—National Institute of Corrections—presented on the fundamental principles of pretrial release and detention in the United States and provided a framework for a model pretrial justice system. .

V. RESOLUTION 2016-01

Atty. Ullmann provided background on the resolution including the proposal review process and the University of Maryland proposal. Atty. Ullmann moved adoption of resolution 2016-01. The resolution was adopted unanimously after discussion.

VI. INITIAL REPORT: CERTIFICATES OF EMPLOYABILITY PROGRAM EVALUATION

Consideration of the initial report was postponed to the next meeting.

VII. OTHER BUSINESS

Executive Director Tsarkov provided a brief update on the status of the two Commission recommendations under consideration by the General Assembly this session.

Atty. Ullmann expressed concern that meeting minutes do not provide an adequate summary of presentations. Discussion followed.
