FOR THE PAST 26 YEARS I HAVE WOKEN UP EACH MORNING THINKING OF [REDACTED] AS WELL AS THE REGRET AND REMORSE I FEEL FOR MY ROLE IN HER DEATH. I WILL ALWAYS HAVE AND FEEL GUILT DUE TO MY BEING INVOLVED WITH THIS UNFORTUNATE EVENT. THROUGHOUT MY YEARS OF SOUL SEARCHING I UNDERSTAND HOW MY LACK OF ACTION TO PREVENT HER DEATH THAT MORNING WAS CONSIDERED EQUAL TO THE ROLE OF THE PERSON WHO MURDERED HER.

I WAS 17 YEARS OF AGE AT THE TIME THIS HAPPENED. THROUGH MY YEARS OF REFLECTION SINCE I SEE HOW SELF CENTERED AND IGNORANT I WAS IN MY TEENAGE YEARS MY MAIN GOAL WAS TO OBTAIN ANYTHING TO INEBRIATE MYSELF AND TO TAKE MY MIND AWAY FROM THE LIFE I WAS SUBJECTED TO. THIS ULTIMATELY LEAD TO MY POOR JUDGEMENT AND THE EXISTENCE I SUFFER TODAY.

I REGRET THAT I CANNOT CHANGE MY ACTIONS OF THAT MORNING. IN TURN I HAVE STRIVED TO MAKE SURE THAT THE SENTENCE IMPOSED UPON ME WAS NOT DONE IN VAIN. I HAVE LEARNED FROM MY MISTAKES. I HAVE KEPT MYSELF FROM BEING INVOLVED WITH GANGS OR GANG RELATED ACTIVITIES, EVEN AT THE RISK OF MY OWN SAFETY. I HAVE NEVER HAD A MAJOR INFRACTION OR AN INCREASE IN MY SECURITY LEVEL. I WAS SEVERELY ASSAULTED REQUIRING SURGICAL MEASURES AND CHOSE NOT TO RETALIATE. THIS HAS ALL BEEN A RESULT OF ADDRESSING MY ANGER AND SUBSTANCE ABUSE ISSUES. I FEEL THAT MAKING THESE POSITIVE CHOICES AND BY LIVING A HUMBLE LIFE ARE TRULY THE ONLY WAYS TO MAKE AMENDS. WHILE I AM INCARCERATED FOR MY ACTIONS OF THAT MORNING.
