#### I. MEETING CONVENED

## II. ADOPTION AND SAFE FAMILIES ACT PROPOSAL

Atty. Maureen Price-Boreland and Atty. Christine Rapillo explained the Adoption and Safe Families Act Proposal that came from the Subcommittee on Collateral Consequences. After the discussion, the Commission unanimously approved the proposal to forward to the Judiciary Committee for the 2019 Legislative Session.

  - i. We don't have to decide on this tomorrow, but it might make sense to start a conversation about what to do with this one next session. We can reintroduce the same thing as we typically do when something doesn't pass. However, I'm not sure how we do that if we can't solve the question with the proposed assessment/classification board. Since the Board of Pardons and Paroles is adamantly against it and no other agency really wants to house this body, then we may want to amend the proposal and focus solely on the removal process
