## I. MEETING CONVENED

• Judge Robin Pavia convened the meeting at 3:31 p.m.

#### II. APPROVAL OF MINUTES FROM THE 3.27.2025 MEETING

• The minutes from 3.27.2025 were approved.

## III. REMEMBERING ROBERT FARR

• Judge Pavia acknowledged the passing of Robert Farr, who served on the Commission for 10 years.

## IV. WELCOMING NEW MEMBER LEN FASANO

- Judge Pavia welcomed former Senator Len Fasano, who was recently appointed to the Commission. John Santa and Bill Dyson also offered words of welcome.
- Fasano expressed his appreciation and shared his enthusiasm about joining the Commission.
- Commission members introduced themselves to Fasano.

## V. LEGISLATIVE UPDATE

- Judge Pavia updated members on the results of the 2025 legislative session.
- The Commission submitted two proposals this session, both of which were included in House Bill 7259.
  - The first proposal was brought forward by Inspector General, and former Commission Chair, Robert Devlin. It sought to close a loophole in the police

chokehold statute by permitting chokeholds in defense of a third party, rather than just in self-defense.

☐ The proposal remained in House Bill 7259, which passed both chambers and was signed into law as Public Act 25-29.

The second proposal sought to expand eligibility for the Supervised Diversionary Program to individuals with intellectual disabilities and autism.

☐ The proposal was included in the version of the bill that passed the Judiciary Committee but was removed from the bill in the House of

## VI. COMMITTEE UPDATES:

a. Steering Committee:

Representatives.

- i. Recognizing Outgoing Executive Director Alex Tsarkov
  - Judge Pavia thanked outgoing Executive Director Alex Tsarkov for his service to the Commission and wished him well in his new role on the Board of Pardons and Paroles.
- ii. Executive Director Search Process
  - Ken Barone provided an update on the ongoing search process.
    - The Search Committee is currently finalizing the position description. Once completed, the Committee will post the position, conduct interviews, and identify qualified candidates.
    - The Committee aims to conclude the process in the fall.
  - Bill Dyson asked a clarifying question.
- iii. Recommendation: Designation of Interim Executive Director
  - Judge Pavia introduced Rich Sparaco, whom the Steering Committee unanimously voted to recommend as Interim Executive Director of the Commission.
  - Sparaco introduced himself to Commission members.
  - Bill Dyson and Jennifer Zito expressed their support for the appointment.
  - John Santa noted that the Steering Committee would develop a scope of services for the interim role.
  - The Commission unanimously voted to formally offer Sparaco the position.

- b. Mental Health Subcommittee:
  - i. Update on Intellectual and Developmental Disabilities Study Rachel Mirsky, Esq., Staff Attorney, Disability Rights Connecticut
    - Rachel Mirsky provided the update.
      - The report remains on track for completion by its statutory deadline at the end of 2025.
      - The research team has conducted legal research, examined best practices, and interviewed a broad range of individuals from both the criminal justice and healthcare systems.
      - Notify Mirsky if you, or anyone you know, are willing to participate in a confidential interview.
    - Bill Dyson asked a follow-up question.

# ii. Other Updates

- Jennifer Zito provided the update.
  - The Mental Health Subcommittee continues to oversee progress on various reports, including (1) the Yale SEICHE Center study examining access to mental health services for individuals reentering society; (2) the Competency to Stand Trial report; and (3) the behavioral health diversionary program resource.
  - The next Subcommittee meeting is scheduled for July 14.
- Mike Gailor asked a follow-up question.
- c. Criminal Procedure and Sentencing Subcommittee
  - Judge Pavia announced that Deborah Del Prete Sullivan will be appointed as co-chair of the Criminal Procedure and Sentencing Subcommittee.
  - Pavia reported that Judge Martin Cronin has completed the comparative section of the pretrial report. A draft has been shared with the Subcommittee co-chairs.
    - Both the comparative and quantitative sections of the pretrial report are expected to be completed by the end of the summer.
  - Mike Gailor reported that the Subcommittee continues its work on the hate crimes and human trafficking reports.
- VII. PRESENTATION ON DOMESTIC VIOLENCE MURDER STUDY Dr. Lydia Wileden, Assistant Research Professor, Institute for Municipal and Regional Policy
  - Dr. Lydia Wileden presented on the domestic violence murder study.

- The study includes a comparative legal analysis and an examination of 20 years of murder and manslaughter data.
- o Dr. Wileden reviewed the initial findings with the Commission.
- The research team will continue analyzing the data and drafting the report, and is seeking to engage with the Criminal Procedure and Sentencing Subcommittee as the work progresses.
- Mike Gailor, Anna VanCleave, Deb Sullivan, and Bill Dyson asked follow-up questions.

- Andrew Clark informed members about the upcoming National Association of Sentencing Commissions (NASC) Annual Conference, which will be held on August 11–12 in Madison, Wisconsin.
